2016 National ASCLS Meeting Report: by Michelle Reeve, Pres-Elect

Philadelphia. An important city of our nation's history. So many things happened here that helped in our quest for independence, which makes things possible today in our country. And one benefit of that is that we have the right and ability to form a society for our profession and meet together in national, regional, and state meetings. This is ASCLS, the voice of our profession.

I had the wonderful opportunity to attend the National Meeting this year and can now say I definitely look forward to attending again in the future. This was such an amazing opportunity to network with others in our profession around the country, listen to fascinating speakers and attend CE sessions, and to learn more about our society. I never realized how much our society plays a vital role in the curriculum taught at universities for MLT/MLS programs, the role it plays and watches out for us in legislation and government issues regarding our profession, and the vast body of knowledge contained within our society and our members.

This is a volunteer organization and the members involved in leadership positions are involved because they want to be, not because they have to or because they are paid to. I saw such passion and dedication from some of our National ASCLS leaders, session speakers, and those attending



sessions-it made me more appreciative of our profession and all the amazing people in it.

Turning now to a few key highlights of some of the CE sessions I attended, one new bit of info I learned was that Hematopoietic Stem Cell Transplants

(HSCT) now have application in nonmalignant conditions such as Acquired Aplastic Anemia, Sickle Cell Disease, and Thalassemia. Going deeper into Thalassemia, another session focused just on this and discussed blood transfusions, iron overload testing (MRI is now more reliable than traditional serum iron studies), iron chelation, and again the use of HSCT. Another interesting topic was that more is being discovered about platelets and that they have a role in inflammation and infection in addition to hemostasis.

Lastly a topic I found particularly interesting because I work a lot in blood bank is blood Pathogen Reduction (PR). Pathogen Reduced blood products (plts right now and prbcs to follow) will now become the new standard for blood prod-

ucts. This will not replace the traditional infectious disease testing performed on donor blood products, but will help reduce the transmission of emerging pathogens, such as Zika Virus, and also decrease the rate of bacterial contaminants.

All in all, this was an amazing meeting to attend and we had a great delegation there representing Idaho.


navigate. It is important to recognize that the home page for ASCLS is the face we present to the public. It is our front door that welcomes people into our organization.

"Do you need any time off in August?" they asked me. I thought for a moment. Elk season wasn't until September. Oh wait, I've got that alternate delegate thing. When was that ASCLS convention again? I am pretty sure I threw the packet away. Oh well, I'm just an alternate, it's not like they will need me to actually go. "Nah, I'm good for August" I replied. "Good, because we've got Cerner training that first week, so we'll be shortstaffed."

And short-staffed they were while I was two time zones away in the City of Brotherly Love!

For me, the ASCLS National Meeting was an exceptional and inspiring experience for several reasons. First, it breathed new life into my career. I spent the first part of my career as a generalist bench Tech while I got married and started my family. At almost forty, I'm no longer a newlywed and my boys no longer have me in the 'toddler trenches'. I now have a little freedom to focus some energy elsewhere. The National Meeting was a perfect kick-start for that. It was like our Spring Convention to the tenth power. There were people from all over our great nation that held a burning desire in their hearts to improve quality, create and implement change for every patient that interacts directly or indirectly with the



Laboratory. The level of dedication, competency and organization I witnessed in the nationwide leadership of ASCLS—all gathered in one place was something I never experience before.



Second, the ASCLS National Meeting gave me the tools and resources I need to move forward with my career step in my lab. The National Meeting has implemented the Advanced Management Institute (AMI) which is a two-day set of course designed for managers. This year's primary focus was finance, so I learned about managing FTEs, managerial accounting, informatics, billing for blood product and financial models. Also, it was a great opportunity to network. I have a collection of gracious professionals that I can call with questions.

Last, the ASCLS National Meeting solid-

ified for me the benefits of being an ASCLS member. At the minimum, ASCLS offers resources for us to do our jobs, maintain our knowledge and be apprised of new technologies. However, there is so much more to ASCLS than that!

In our profession, the bench tech has a few options for advancing their career. Inside the lab this

usually includes moving to Lead Tech or Department Coordinator. There's the option to specialize—if you want to. Outside the Lab there's the option moving to Point of Care, but those positions aren't always available. There is the option of Technical Service or sales for a manufacturer, or becoming an educator.

This certainly isn't an exhaustive list, however with these career routes require choices to be made and the loss of bench skills. Many techs have had to decide: Am I ready to leave the bench? If you're not, then what do you do with the desire to advance your career? What do you do if there is no ladder for advancement in your facility? What do you do with that desire to make a bigger difference while you're the night tech at a 500-bed facility?

With ASCLS, there are *many* opportunities to advance your career, make real change, valiantly fight the broken system, learn new skills, and meet new people all while maintaining your bench skills. There are local, regional and national committees for every aspect of our profession: Patient Safety, Leadership Development, Political Action, Education, Scientific Assembly, Mentoring, Product

What's Going On with Our Licensure Effort?

After a summer slowdown in our licensure effort, it's time to renew and strengthen our activities for this important work. The Idaho Legislature convenes Monday, January 9 for its 2017 session with several new legislators elected in the November, 2016 election and many returning supporters of our efforts. We will need to be prepared from the beginning of the session to present our legislation and to be able to explain why this legislation is so important to Idaho's healthcare system.

It will be critical for all of us to introduce ourselves and our issue to each of our legislators in the next couple of months, and convince them to give us their support. Licensure is a non-partisan issue that legislators on both sides of the aisle can support as it relates to patient health and safety. We need to help our legislators understand the risks that patients encounter when uncertified people perform laboratory testing.

Our colleagues from the state of Texas

have also been working on state licensure, and have written a great article explaining why licensure for laboratory professionals is so important. It is very well written and the information in it can help you explain to legislators why this legislation is so important. Please take a few minutes to read <u>this article</u>.

If legislators in your district are running unopposed (go <u>here</u> to find out who your legislators are), you can approach them now to talk to them about our licensure bill.

The bill is available <u>here</u> if they (or you!) would like to read it. It is a draft bill, but we do not anticipate that there will be significant changes.

If your legislators are running in contested races, you will need to wait until after the November 8 election to see who will be representing you in 2017. That will give us only 2 months to contact those legislators, so we will need to be ready to get in touch with them very soon after Election Day.

It will be critical for all of us to participate in this process if we expect to be successful. Please do a little reading, and contact your legislators as soon as you know who they are. Only with their support can we be successful in licensing laboratory professionals in Idaho!
