# GOVERNMENT AFFAIRS UPDATE: DEBBIE SHELL

The Allied Health Professional Shortage Act (H.R. 6302), sponsored by Rep. David Cicilline (D-RI), was introduced in the House of Representatives on March 19, 2020, and was referred to the House Committee on Energy and Commerce. This legislation would provide scholarship and loan payment programs for allied health professionals, with a period of obligated service in personnel shortage areas, and would authorize \$25 Million from 2021-2025. There is currently no Senate companion bill.

Identical versions of the **VALID Act of 2020** (H.R. 6102/Sen. 3404) were introduced in the House (Rep. Diana DeGette [D-CO] and Rep. Larry Buschon [R-IN]) and the Senate (Sen. Richard Burr [R-NC] and Sen. Michael Bennet [D-CO]) on March 5, 2020. This legislation was referred to the House Committee on Energy and Commerce and the Senate Committee on Health, Education, Labor and Pensions, and creates a new laboratory test category called "in vitro clinical tests" (IVCT), currently referred to in the laboratory community as laboratory developed tests. It gives the Food and Drug Administration (FDA) the authority to review and approve these tests using a risk-based framework, and would "grandfather" all current IVCT's, with new high-risk tests required to go through pre-market review.

Also related to laboratory developed tests, the **Verified Innovative Testing in American Laboratories Act of 2020, or VITAL Act of 2020,** was introduced in the Senate by Senator Rand Paul (R-KY) on March 17, and was referred to the Senate Committee on Heath, Education, Labor and Pensions. This legislation grants CLIA, through the Public Health Service Act, governing authority for all clinical laboratory tests, including laboratory developed tests, with no Food and Drug Administration (FDA) involvement. CLIA would maintain this authority during emergencies, such as pandemics, to ensure expediency in laboratory testing as the primary goal of this legislation.

Legislation placing the collection of laboratory pricing data on hold for one year (part of **The Protecting Access to Medicare Act of 2014 [PAMA])** was passed in December, 2019 as part of federal budget legislation. A review of the processes for collecting and using this data for laboratory testing reimbursement has been referred to the Medicare Payment Advisory Commission (MedPAC), with the goal of ensuring that the data collection process truly reflects the laboratory market-place, as was intended by the original legislation.

ASCLS Executive Vice President Jim Flanigan, ASCLS Legislative Affairs Consultant Patrick Cooney, ASCLS President Cindy Johnson, and the ASCLS Government Affairs Committee have been sharing aspects of the impact of **COVID-19** on clinical laboratories with Congress, the White House Coronavirus Task Force, federal agencies such as FDA and CDC, and other laboratory associations. Work continues by these individuals and groups, as well as individual ASCLS members, to make sure all ASCLS members are well-informed, and to assist in any way

possible to ensure laboratory professionals have access to resources for answering their questions. Many of the ASCLS Communities, as well as the Open Forum, have had extensive discussions regarding laboratory impacts and shared solutions for members, including educators and students.

The January/February issue of ASCLS Today was focused on advocacy, with many articles giving examples of how we can all advocate for ourselves in our workplace and for our profession. The ASCLS website also has an advocacy center with great infor-

mation and resources. ASCLS is sponsoring monthly webinars about leadership topics, including advocacy.

We need all members to be educated about how they can become effective advocates.

# IT'S NATIONAL MEDICAL LABORATORY PROFESSIONALS WEEK MECHELL REEVE, MLS (ASCP)<sup>CM</sup> ST. LUKE'S MAGIC VALLEY LAB

Did you know that approximately 70% of a patient's medical record is laboratory data? We are often just referred to as "the lab," but who are we and what do we do? **Phlebotomists** draw patients' blood and send it to the lab where it is received and distributed to the appropriate depts by Specimen Processors. Then in the various depts of the lab (Hematology, Chemistry, Blood Bank, and Microbiology) **the Medical Laboratory Scientists**

(MLS) do the technical processing and analysis of the samples.

Depending on the test ordered and the sample type, the MLS use very advanced instrumentation to analyze some tests/samples, some tests are done on an individual test cartridge, and some tests require manual hands-on analysis with microscopes, centrifuges, reagents, and/or our eyes.

For surgical samples, some are sent to the pathology dept where the sample is received and then "grossed" (measured, assessed, and cut) by the **Pathology Assistant**. Then the sections of tissue that need further analysis for possible infection, malignancy, or abnormalities are processed and stained by Histology Techs and then the final slides are given to the Pathologists to review.
